- SPECIAL EXCEPTION HEARING- \$1,200 (plus any cost to Watson Township above the \$1,200 for attorney fees, stenographer, etc)
- ORDINANCE VALIDITY CHALLENGE OR REQUEST FOR INTERPRETATION HEARING- \$125.00
- ORDINANCE AMENDMENT AND/OR MAP CHANGE HEARING-\$125.00
