WATSON TOWNSHIP MEETING OCTOBER 19, 2022

The Watson Township Board of Supervisors held their monthly meeting on October 19, 2022, at 7:00 pm at the Watson Township Municipal building, with James Seltzer and James Potter present.

Also Present: Wilbur Moore, Charles Knar, and Zoning Officer Brent Petrosky

Chairman Seltzer called the meeting to order and led the Pledge of Allegiance.

Chairman Seltzer asked if there were any questions or comments on the September 15, 2022, monthly meeting minutes, there being none, Supervisor Potter made a motion to approve the minutes as presented; seconded by Chairman Seltzer, MCU.

Chairman Seltzer asked if there were any questions or comments on the October 10, 2022, special meeting minutes, there being none, he then made a motion to approve the minutes as presented; seconded by Supervisor Potter, MCU.

Chairman Seltzer asked if there were any questions on the Treasurer's Report, there being none, Supervisor Potter made a motion to approve the Treasurer's Report as submitted; seconded by Chairman Seltzer, MCU.

Correspondence: None.

Roadmaster's Report:

- 1. The Supervisors plan to contact Earl Lee Strobel regarding plowing again this Winter for the township. They also plan to contact Judd Welshans about the possibility of plowing for the township in the event the township's plow truck is out of service.
- 2. Pipe on Dennison Hollow Road subcontract out the pipe replacement project. Chairman Seltzer will contact a couple local subcontractors.

Zoning Report:

Zoning Officer Brent Petrosky provided updates on permits:

Emergency Management Coordinator Report:

Chairman Seltzer agreed to contact Emergency Management Coordinator, Denny Bottorff to ask him to act as a temporary EMC for Watson Township until the position is filled.

Recreation Committee Report:

Chairman Seltzer said he reached out to a couple local contractors about installing the new playground equipment and they were not interested due to liability concerns. He said on the recommendation George Ely Associates, he reached out to Willow Playworks in Mifflinburg, and they agreed to install the equipment next Spring.

Old Business:

Well at Township Municipal Building

The Supervisors tabled discussion of the well at the Township Municipal Building.

Chairman Seltzer reported that the well pump at the ball field is still not working, and noted that there is no pressure. He had Denny Bottorf looked at it to see if they could resolve the problem but were unable to determine if there is an issue with the pump or the "brain box".

Pipe Replacement along Dennison Hollow was discussed during the Roadmaster's Report.

Certificate of Deposit

The Board discussed opening a certificate of deposit and current interest rates.

It was the consensus of the Board to look at interest rates again in November.
