The Watson Township Board of Supervisors held their monthly meeting on January 18, 2024, at 7:00 pm at the Watson Township Municipal building, with James Seltzer, James Potter, and Richard Macklem present.

Chairman James Seltzer called the meeting to order and led the Pledge of Allegiance.

Chairman Seltzer asked if there were any questions or comments on the December 21, 2023, monthly meeting minutes, there being none, Supervisor Macklem made a motion to approve the minutes as presented; seconded by Supervisor Potter, MCU.

HRI is offering monetary reimbursement and possibly install guiderail that is being removed along Rte. 44 on West Side Road for the Township.

Spencer Boone, General Superintendent for HRI, Inc. requested to meet with the Supervisors during the work day to discuss the proposal.

Supervisor Potter made a motion to meet with Mr. Boone and work on details of the proposal from HRI, Inc. to use the municipal building; seconded by Supervisor Macklem, MCU.
