WATSON TOWNSHIP MEETING MARCH 20, 2025

The Watson Township Board of Supervisors held their monthly meeting on March 20, 2025, at 7:00 pm at the Watson Township Municipal building, with James Potter, and Richard Macklem present.

Also present: Juanita Hull, Wilbur Moore, Rich Lange, Chris Rupped, Allen Green, Paul Fye, Wm. Dennis Buttorff, EMC, and Zoning Officer Brent Petrosky

Supervisor Potter called the meeting to order and lead the Pledge of Allegiance.

Bid Opening – 2025 Soil Nailing Road Project

The Supervisors received two bids for the 2025 Soil Nailing Road on West Side Road, as follows:

Mar-Allen Concrete Products, Inc.	\$163,404.00
Access Limited Construction	\$ 89,616.43

Supervisor Macklem stated that the township received funding from the Lycoming County Soil Conversation District through the Dirt, Gravel and Low Volume Road Program in the amount of \$81,900.00 and the township would have to pay the difference between the funding received and the cost of the project.

Supervisor Macklem made a motion to accept the bid from Access Limited Construction in the amount of \$89,616.43; seconded by Supervisor Potter, MCU.

Meeting Minutes:

Supervisor Potter asked if there were any questions or comments on the February 20, 2025, monthly meeting minutes, there being none, Supervisor Macklem made a motion to approve the minutes as presented; seconded by Supervisor Potter, MCU.

The Board reviewed the Treasurers Report and Supervisor Potter made a motion to approve the report as submitted; second by Supervisor Macklem, MCU.
